HORSE LEASING CONTRACT

This agreement ("Agreement") is made and entered into on [date] by and between [Lessor's Name], with a mailing address of [Lessor's Address] ("Lessor"), and [Lessee's Name], with a mailing address of [Lessee's Address] ("Lessee"), collectively referred to as the "Parties."

LEASED HORSE

Lessor hereby leases to Lessee, and Lessee hereby leases from Lessor, the following horse:

TERM OF LEASE

The lease term shall begin on [Start Date] and shall end on [End Date], unless otherwise terminated earlier in accordance with the terms of this Agreement.

LEASE PAYMENT

Lessee agrees to pay Lessor the sum of [Monthly Lease Payment] for the lease of the horse during the lease term. Payment shall be made on the [Due Date] of each month, and shall be made in [Currency]. Payment shall be made to [Lessor's Payment Information].

USE OF HORSE

Lessee shall use the horse solely for [Intended Use], and shall have the following options for the number of days per month that the horse can be used by Lessee:

- Option 1: Full month
- Option 2: [Number] days per month
- Option 3: [Number] days per week
 - Monday
 - Tuesday
 - Wednesday
 - Thursday
 - Friday
 - Saturday
 - Sunday

Lessee shall not use the horse for any other purpose without the prior written consent of Lessor. Lessee shall not allow any other person to ride the horse without the prior written consent of Lessor.

CARE OF HORSE

Lessee shall provide the horse with proper and adequate care, including but not limited to food, water, and shelter. Lessee shall keep the horse in good condition, and shall promptly notify Lessor of any injuries or illnesses suffered by the horse.

MAINTENANCE OF HORSE

Lessee shall have the following options for maintenance of the horse:

- Option 1: Lessee shall be responsible for all routine maintenance and veterinary care required by the horse during the lease term.
- Option 2: Maintenance and veterinary expenses shall be split 50/50 between Lessor and Lessee.
- Option 3: Lessor shall be responsible for all routine maintenance and veterinary care required by the horse during the lease term.

Lessee shall promptly notify Lessor of any necessary maintenance or veterinary care, and shall obtain Lessor's approval before arranging for such care.

STALL LOCATION

The horse shall be stalled at [Stable Name and Address], located in the Emirate of [Emirate Name]. The Lessee shall be responsible for any stall fees associated with the horse during the lease term.

TERMINATION

Either Party may terminate this Agreement upon [Notice Period] days' written notice to the other Party. In the event of a termination, Lessee shall return the horse to Lessor in the same condition as when received, except for reasonable wear and tear.

INDEMNIFICATION

Lessee shall indemnify and hold Lessor harmless from any and all claims, damages, or liabilities arising out of or in connection with Lessee's use of the horse during the lease term.

GOVERNING LAW

This Agreement shall be governed by and construed in accordance with the laws of the United Arab Emirates.

ENTIRE AGREEMENT

This Agreement constitutes the entire agreement between the Parties and supersedes all prior and contemporaneous agreements and understandings, whether written or oral, relating to the subject matter of this Agreement.
